**Proposal to change the seasonal no waiting to no waiting at any time from Valency up Penally Hill.**

Cllr Simmonds proposed the council seek to include limited time waiting all year from Valency down to the Spar shop with a limit of 30 minutes. Seconded by Cllr Edwards-Symons. All in favour.

## **Plan 2 - Dunn Street and Fore Street**

**Proposal – to reduce no waiting zone by 5m at top of Fore Street.**

**Proposal – to keep existing no waiting zone in Fore Street opposite and either side of Gunpool Lane.**

Cllr Simmond proposed the council support the two proposals. Seconded by Cllr Munden. All in favour.

**Proposal – no waiting at any time from Community Centre up to the school.**

Cllr Ferrett proposed the council reject this proposal. Seconded by Cllr Brewer. All in favour.

## **Plan 3 – Doctors Hill**

**Proposal – to have no waiting on both sides of the road from Gunpool lane to doctors’s surgery**

Cllr Munden proposed the council seek amendment to the above proposal to include two parking spaces from Chy-Gwlan vehicle access towards Gunpool Lane. Seconded by Cllr Simmonds.

**Proposal - to have no waiting either side of the road outside the doctor’s surgery with a section of limited time parking zone on doctor’s side of road.**

Cllr Ferrett proposed the council seek to maximise the are of limited time parking and for it to be limited to one hour with no return within 3 hours for 8am until 6pm. Seconded by Cllr Edwards. All in favour.

**Proposal – to have no waiting on either side of the road from Lundy View to High Street and Fore Street.**

Cllr Edwards proposed the council support this proposal. Seconded by Cllr Edwards-Symons. All in favour.

## **Plan 4 – Old Road**

**Proposal – to have various section of no waiting from ivy Cottage to the Wellington.**

Cllr Ferrett proposed the council reject this proposal. Seconded by Cllr Brewer. All in favour.

## **Plan 5 – New Road**

**Proposal – to have no waiting on either side of the road from Forrabury Hill up to The Chestnuts.**

Cllr Simmonds proposed the council reject this as no obvious need as no issues have been raised. Seconded by Cllr Ferrett. All in favour.

**Proposal – to amend seasonal (double yellow) ‘No waiting 1<sup>st</sup> may to 30<sup>th</sup> September’ to (single yellow) in accordance with current regulations.**

Cllr Ferrett proposed the council support Cornwall Council need to amend the signage in accordance with current regulations. Seconded by Cllr Simmonds. 6 in favour 2 against.
