**11.01 Apologies** – None received

**11.02 Declarations of Interest** –

Cllr Brewer declared an interest in item 11.06 Boscastle Football Club and item 11.10 Planning Application PA11/04808.

**11.03 Public Participation** – 3 members of the public present

- A member of the public stated that if the Council were happy with the minutes of the last meeting they would also be content for them to be signed off, and the matters relating to Trevalga sewage works be finished with and not spoken about again.
- Another member stated that at the last meeting another member of the public (not present at this meeting) made derogatory signs towards them, and stated they can't take much more of this, they find this business really stupid. They support the previous member of public's comments and asked is it possible to finish this business off. Cllr Jarvis asked for it to be recorded that it is inappropriate for personal abuse to be raised at these meetings.
- A member of the public raised the issue from the last meeting re declarations of interest. Cllr Jarvis responded that he had sought guidance from the Standards Committee by offering a theoretical case. The result of which had now been actioned. The Clerk read out an apology letter from Cllr Brewer for any misunderstanding.

**11.04 Minutes**

**11.05 Matters to report (only) from previous meetings minutes**

Cllr Day reported back on the meeting arranged for Friday 8<sup>th</sup> July with the National Trust on the stiches. Only Councillor Day attended. National Trust (NT) and Natural England want cattle to graze on the stiches. Cllr Day suggested the pathways be rolled to help maintain a reasonable footpath during the grazing period NT agreed with this and propose to roll the path at the end of Nov, Dec, Jan and after cattle leave. The Clerk to write to NT apologising for poor attendance and requesting a follow up meeting in September to discuss further options. Cllr Rodda commented on item 8.11 from the meeting of 9<sup>th</sup> June 2011, concerning the statement from CClr Brown. Going on to explain that if we were in step with the normal
