03.01 Apologies – None received

03.01a Election of Chairperson – Cllr Smith proposed Cllr Ferrett continue in the role of chairperson. Seconded by Cllr Jarvis. All in favour. **Resolved.**

03.01b Election of Vice Chair – Cllr Irving Little proposed Cllr Hockin continue in the role of vice chair. Seconded by Cllr Smith. All in favour. **Resolved.**

03.01c Appointment of councillor representatives for 2012/13 – Cllr Brewer proposed that the appointments made for 2011/12 be continued for 2012/13. Seconded by Cllr Hockin. All in favour. **Resolved.**

03.02 Declarations of Interest – Cllr Hockin declared an interest in planning application PA12/03794 if the council resolved to consider the application on this agenda.

Cllr Dawson declared an interest in planning application PA12/03584.

Cllr Brewer declared an interest in the item Football Club funding.

03.03 Public Participation – 8 members of the public present

Mr Steege raised concern that the item 1.03 in the minutes relating to Blowhole Article could be misinterpreted. Cllr Jarvis would seek a minor amendment when the minutes are considered for approval.

Mr Bannister expressed his disappointment at the lack of attendees to the Annual parish meeting and asked if all the organisations of the community had been invited. The Clerk confirmed all had received an individual invite. Mr Bannister also asked the council to consider getting a speaker for the next Annual Parish meeting.

Mr Bannister asked if the Council are no longer recording the meetings. The Clerk responded that the Council would only record if the Councillors resolved to do so for a particular agenda item.

Mr Steege recounted the Council annual report for the Annual Parish meeting in that it has difficulty in communicating with Cornwall Council. In light of this will the council consider inviting Cornwall Councillor Brown to future meetings. Cllr Ferrett advised that this would be discussed later in the agenda.
