Highways – Cllr Edwards asked if there was any further development regarding the flue in potters lane which protrudes into the highway. Clerk advised the Cornwall Council had refused the retrospective application. Cllr Chater reported incidents of motorhomes using Fore Street (directed via Sat Nav) and getting stuck and damaging roofs. Cllr Chater proposed the Council ask Cornwall Council for signage to stop this route being used. Seconded by Cllr Rodda. All in favour. Cllr Bright reported vehicles parking opposite the school entrance opposite the zig zag school entrance markings causing extreme difficulty for vehicle to safely use the road at school times. Cllr Bright proposed the council ask Cornwall Council regarding pupil safety. Seconded by Cllr Rodda. All in favour.

Clerk asked to report the street light outside Spar shop not working which impacts on the defibrillator. Cllr Edwards reported that she was aware of another defibrillator that may be available, she will check with the surgery about location. Cllr Edwards proposed if it could be located outside the surgery the council obtain it. Seconded by Cllr Chater. All in favour.
