11.01 Apologies – None received

11.02 Declarations of Interest – None declared

11.03 Public Participation – 5 members of the public present

A member of the public advised the council the proposed sewage treatment plant at Bottreaux filling station would discharge into the nearby water course. The EA were objecting to the planning application on these grounds as the water course is often dry particularly during summer months. Cllr Brewer proposed the council write to Cornwall Council expressing the Parish Council reservations about the original application. Seconded by Cllr Hockin. All in Favour. **Resolved**

11.04 Minutes

Minutes of the meeting held on 14th July 2011 – Cllr Irving Little asked for the names of those who voted against the proposal from item 11.05 to be named. Proposed by Cllr Jarvis the minutes be accepted as a true record and it should be noted in these minutes that Cllrs Day and Irving Little voted against the proposal from item 11.05 of the meeting on 14th July 2011. Seconded by Cllr Hockin. Cllr Smith abstained not at meeting. All in favour. **Resolved.**
